<b>Promoter</b>	The Promoter Organic Crop Protectants a division of DuluxGroup (Australia) Pty Ltd (ABN 67 000 049 427) of 1956 Dandenong Road Clayton, VIC 3168.
<b>Promotion Type</b>	Game of skill
<b>Promotion Period</b>	The Promotion will commence on 15 July 2021 and close on 12 August 2021, or until promotional stock lasts ( <b>Promotion Period</b> ).
<b>Entry Restrictions</b>	<p>This promotion is only open to residents of Australia. Entrants under 18 years of age must get permission from a parent or guardian before entering. Employees (and their Immediate Families) of the Promoter, the Participating Store or any of their respective parent companies, subsidiaries or affiliated companies, or any agencies associated with this promotion are ineligible to enter. "Employees" means any directors, management, employees, concessionaires, consultants, officers and contractors or other such people who perform work under the control of another in exchange for payment.
